SOLUBLE CRYSTAL SPRAY ADJUVANT

GENERAL INFORMATION

ZIPPSOL is intended for use with certain herbicides as recommended on the herbicide labels. Information on the herbicide labels takes precedence over this label. Observe all precautions and geographical restrictions on labels of herbicides and other additives.

CAUTION

This product may cause skin and eye irritation. Be sure to avoid contact with skin and eyes. In case of accidental contact, flush with plenty of water. See a physician if irritation persists. This product may be harmful if swallowed or inhaled. Do not breathe dust or spray mist.

DIRECTIONS FOR USAGE

Read and follow label directions for herbicide as to the procedures, dosage rates, timing of application and restrictions for the crop on which the herbicide is to be applied.

Add ZIPPSOL slowly to tank when water level is at 3/4 of the desired amount and agitation has begun, but before herbicide is added. Recommended Use Rates: 8-20 lbs. per 100 gallons of water or as directed by chemical manufacturer's label. Allow enough time for the crystals to dissolve completely before adding additional adjuvants or herbicides. Continue agitation and complete filling of the spray tank.

ZIPPSOL solutions may be corrosive to the metal parts of sprayers or other equipment. Flush tank, pump, boom, nozzles, and the entire spray system thoroughly with water.

STORAGE

Store in a safe manner in the original container only. Keep in a cool, dry place. When local conditions such as humidity or pallet overhang might affect package strength, reduce stacking height.

DISPOSAL

Dispose of this bag in an environmentally safe manner as recommended for your area.
